

# WEST VIRGINIA WESLEYAN COLLEGE?



West Virginia Wesleyan is a traditional residential liberal arts college nestled in the mountains of West Virginia in the town of Buckhannon, WV. # What is the John W. REGER SOCIETY?

The John W. Reger Society is named after one of our first trustees and major benefactors. It is a cumulative recognition society for those persons who make Wesleyan a part of their estate or gift planning.

Membership may be secured by including the college in your will, making Wesleyan the owner or beneficiary of insurance policies, or by participating in any of the various lifetime income plans the college has available.

Membership in the Society will be permanent; that is, it will continue from year to year throughout the member's lifetime so long as the commitment remains in effect.



### SAMPLE BEQUEST LANGUAGE

I {name}, of {city, state, zip} give, devise and bequeath to West Virginia Wesleyan College, a non-profit 501(c)(3) corporation located in Buckhannon, West Virginia, {specific amount or percentage of the estate or description of property} residue and remainder (or state all, a specific dollar amount, or a percentage) for {its unrestricted use and purpose} or {for such purpose as the Trustees of West Virginia Wesleyan College shall determine to be in the best interest of the College}.

### **ESTATE PLANNING OVERVIEW**



#### 1. WRITE DOWN WHAT IS IMPORTANT

The first step in the estate planning process is to gather information about yourself, your loved ones, your passions, and the property you own.



#### 2. SPEAK WITH AN ATTORNEY

Talk to a knowledgeable estate planning attorney who can prepare the necessary legal documents, such as a will, trust, or medical directive.



#### **3. UNDERSTAND YOUR PLAN**

A good plan will promptly transfer your property to the beneficiaries you select. Property can be transferred by a will or trust, a deed, or beneficiary designation.



#### **4. SIGN YOUR DOCUMENTS**

Your plan is not effective until you sign your estate documents.



## 5. INFORM WEST VIRGINIA WESLEYAN COLLEGE

Inform WVWC and submit John W. Reger Society form.

Bequests also may be directed to purposes or operating programs of **special interests** to donors. In addition, bequests may be designated to the College's permanent endowment fund for **unrestricted use** or for supporting such purposes as **scholarships**, **academic departments**, **faculty salaries**, or other special areas of donor interest.
